- 3、不给予“相关人员”（包括但不限于：贵公司员工的近亲属及关系密切的其他亲属和朋友、评标人员、贵公司聘请的招标代理机构及其工作人员等）上述不正当利益；
- 4、不接受贵公司贵公司员工和“相关人员”在我公司做兼职、顾问等；
- 5、若贵公司员工和有关人员向我公司索要不正当利益，我公司将立刻拒绝该不当要求，并立即将情况据实通知贵公司；
- 6、在贵公司提出要求下，我司将积极配合贵公司对有关商业贿赂情况的调查；
- 7、上述承诺事项均为本公司真实意思表示，若我公司违反上述承诺，自愿接受以下处罚：
 - （1）贵公司有权取消我司的投标资格；
 - （2）给贵公司造成的经济损失我司将予以赔偿；
 - （3）构成犯罪的可提请司法机关调查处理，依法追究刑事责任。

Anti-commercial bribery undertaking

4. Don't allow your company staff and "relevant personnel" do part-time job in our company, or as a consultant and so on;
5. If your company staff and "relevant personnel" ask for any improper interests, we will immediately reject and inform you the situation truthful;
6. According to your request, we will cooperate with your anti-commercial bribery investigation;
7. All the above are our real meaning. If there is a violation of these promises, we voluntarily to accept the following penalty:
 - (1) Cancel our tender qualification;
 - (2) Pay the economic losses caused to you;
 - (3) If constitutes a crime, it can be handled to judicial organ for criminal investigation.
